## Overview

Wolfson Children's Hospital, in partnership with the Florida Bioethics Network, presents the **14th Annual Pediatric Bioethics Conference**.

With talks on pressing issues by experts in the field, the conference will serve as fertile ground for the development and clarification of best practices in pediatric bioethics. It will include sessions on topics such as: Race-Based Medicine, Health and Justice, Intensive Care Decisions for Fragile Neonates, Exploring What it Means to be a "Good Parent", and Moral Distress in the Shadow of a Global Pandemic.
